Wilson read the following: The Rockaway Beach City Council considers it necessary and convenient to further the public interest to sell the property as it is no longer needed for public use.

Shepard stated the counteroffer with the buyer was \$335,000, but that was rejected, the second counteroffer was \$330,000 and that was also rejected. Shepard stated the offer now is \$325,000 and that the buyers have until 5PM today to accept. Hayes stated she believes the buyers are getting a good deal on the building. Walhood asked if the buyer will be paying for the closing costs, Shepard said yes. Walhood asked how long the City must wait to see if the buyer can get the loan for the building, Shepard stated the City already had the buyer's prequalification. Cantrell asked if the City knows what kind of business would be going into the building, Shepard was unsure of what the space would be used for. Shepard stated he has not been seeing many commercial building sales lately, the councilors agreed. The Councilors and Shepard discussed other commercial buildings for sale in Rockaway.

Cheek made a motion, seconded by Cantrell to approve resolution No. 21-965 a resolution declaring real property to be surplus and authorizing city staff to execute necessary documents to convey the property; motion carried.
