PRESENTATONS, GUESTS & ANNOUNCEMENTS

STAFF REPORTS

Fire Chief, Todd Hesse stated the department had 5 trainings withing the last month. Hesse said beach safety had recently started to come on the agenda for patrols again. Hesse mentioned with the recent dry weather the department has received more burn permits. Hesse said the department has looked at neighboring departments for other ideas on meeting the community's need for water rescues services.

Police Chief, Charlie Stewart stated the arrest totals for 2021 have increased since 2020. Stewart said the department has stayed busy with calls in the month of May.

Public Works Director, Rob Morris stated the department has received asphalt, so they have been able to do patch paving and potholes on the roads. Morris said the mechanical issue at the wastewater treatment plant has been resolved. Morris mentioned the city has signed an agreement with The University of Oregon to place a seismic monitoring station at one of the city's water stations. Wilson asked if ODOT has given any indication on how to get a crosswalk at NE 12th street, Morris said they have given him the information.

City Manager, Luke Shepard stated Fire Chief Todd Hesse has completed his first year on the job. Shepard said Hesse has been very successful. The Fire Department responded to over 400 calls in 2020 and this was up from around 250 calls in both 2018 and 2019. Shepard mentioned the Fire Department has been focusing on training. He stated that the Fire Department will go from 2 certified EMT's last year to 10 certified EMTs by September and will soon have 11 certified firefighters. Shepard thanked Hesse for working so hard over the past year. Shepard updated the council on the potential land purchase and said the work over the next few months will open the door to the purchase. Shepard stated at the June council meeting that Tillamook County Sheriff Josh Brown and Matt Kelly the undersheriff will be here to introduce themselves. Shepard mentioned that the grant for a section of the Salmonberry Trail in Rockaway was likely to be funded, but will be funded from federal highway funds. Shepard added that federal highway funds come with many more requirements and that the City will need to make sure it would be able to maintain control of the project and also ensure the funding amount is still sufficient before the grant award is accepted. Shepard discussed the state's requirements for the firework show. Wilson asked if it is only Pacific City and Rockaway having fireworks in Tillamook County, Shepard said yes.
