# **NEW BUSINESS**

# <u>DISCUSSION OF FEDERAL FUNDING FOR SALMONBERRY TRAIL</u> SEGMENT

Wilson read the following: Approximately \$1.6 million in Federal Highway funds have been awarded to design and construct a mile-long segment of the Salmonberry Trail in Rockaway Beach. This trail segment will begin at Washington Street and end near the Wayside. City Manager will provide details.

Shepard stated the city has received an award and ODOT is working on an intragovernmental agreement with the city. Shepard talked about the project background and the city's partnership with Salmonberry Trail Foundation. Hayes asked if Shepard was concerned about losing parking, Shepard said no that he is working on a stipulation to ensure the diagonal parking downtown remains unaffected. McGinnis stated That she and Planning Commission president have gone to several meetings regarding the Salmonberry trail and represented the City of Rockaway.

# **COUNCIL CONCERNS**

Hayes asked what kind of ordinance violations were made, Shepard stated nuisance and trash violations. McGinnis stated she appreciates the opportunity to be on the council. Walhood asked if the police report was online, Shepard said yes, and welcomed McGinnis to the council. Cheek thanked Shepard for doing a great job and welcomed McGinnis.
