## PRESENTATONS, GUESTS & ANNOUNCEMENTS

Scott Fregonese Rockaway Beach city planner presented a "Closer Look on Housing". Fregonese spoke to the council on steps recommended by the Department of Land Conservation and Development to address housing needs in Rockaway Beach and specifically affordable housing in our town.

Nan Devlin, Tillamook Coast Visitors Association Executive Director presented about the Annual Tourism Report and how well Rockaway Beach is doing with new business and restaurants. Devlin

spoke to the council on the website and how many have joined the pages on Facebook and Instagram. Devlin talked about the wish list for Rockaway Beach, such as a sculpture, charging stations for electric vehicles and the trolley.

## **STAFF REPORTS**

Fire Dept: Chief Todd Hesse spoke the about call volume that the Fire dept. responded to during the month of August. During the month of August, the trainings that the department focused on were on hose and nozzle practice and preparing the water rescue equipment for summer calls and ocean rescues. The Apparatus Operator/ Officer development training program continues and is going well, there are 2 in the class every Wednesday, they are advancing their skills and their task book will be completed in September. Medical training focused on airway management. The Emergency Preparedness group and Radio group continue to meet and train. Since September is Emergency Preparedness month the group will be hosting a GO Bag class on September 17<sup>th</sup>. Training on radio and procedures and skills for preparedness continue to be taught. Hesse was proud to announced that the department received a successful AFG Grant, for \$186,000.00 to replace aging SBAs. The burn ban is still in effect, fire pits and fires on the beach are still allowed. Hesse informed the council that the department purchased a burn trailer that the crew will be able to train with live fire in a controlled environment. The Department is exploring options to start a Cadet program.

Sheriff's Office: Under Sheriff Matt Kelly spoke on call volume that they responded to during the month of August. During the month of August, the Sheriff's department responded to an increase in thefts in the area. Kelly encouraged the public to secure their property to help slow down the thieves in the area. Kelly talked about the school being back in session and to make sure everyone slows down around the school along with the side streets since there are so many students out walking.

Public Works: Superintendent Dan Emerson spoke on some of the work that they focused on in the month of August. City Hall is on schedule to get new outside lights, gutters and a paint job. The paint job has been done and the gutters back on and the project looks great! Paving projects are going as planned. Nehalem & Easy Street come out great! Public Works is happy to announce that they received a grant for an overlay paving project. Public Works, worked with Tillamook County Public Works to get NE Lake Boulevard paved from Hwy 101 to the bus entrance. Public works sewer plant impoundment was paved and looks very nice. Emerson stated the sewer plant and collection system are performing great. The White Dove sewer main extension project has started and is expected to go very smoothly. Emerson talked about an exciting project coming together for the 3<sup>rd</sup> street reservoir, this is part of a grant received called the American Rescue plan Act, this project will address the issues found during the inspection.

City Manager Luke Shepard spoke about all city employees being very busy, all the employees have been working very hard during this last month. City hall completed the on-site portion of the annual financial audit during the last week of August. The auditors will present the final audit report upon its completion. This usually happens in December or January. He added that everything went smoothly. He thanked Becca Harth for all her hard work on the audit. Shepard mentioned that the city's new website launched the first week of September and looks great and professional. City hall staff continue to make corrections on issues that need to be sorted out, and feedback is appreciated. Shepard summarized a meeting he attended with members of the DLCD, other city managers and Tillamook County administration. Discussions at the meeting included affordable housing. The DLCD gave out information on the steps to take on how to tackle this issues.

Shepard spoke about the good news of the Fire Department's purchase and delivery of the live fire training container. This will allow the department to have incredible training opportunities. Shepard talked about the AFG Grant that Hesse wrote and was received for \$186,000.00 to allow for new SCBA's/Air packs. Shepard thanked Fire Chief Todd Hesse for all the hard work that he put in to make these happen. Every five years the city reviews the wastewater discharge permit and they are in the final stages.

Training update- The department focused September Thursday night trainings on Structure fire evolutions, Chimney fire suppression tactics and forcible entry. The Apparatus Operator /Officer development training program continues and will be completed in October. DPSST will be performing annual accreditation reviews in the month

Beach Safety continues to be a priority of the department. The focus continues to be on education and safety. During the month of September crews were on the beach 23 times providing information to citizens and visitors. Have been working with State Parks to better coordinate our safety and enforcement actions on the Beach.

Emergency Preparedness group and Radio group continue to meet and train. Repairs to the radio shack have been completed (secured to keep rodents out). Winter storm training is on the agenda for October. The group is also working on getting information out to the public and is still seeking volunteers to help with the program. Plans for the future include pre-disaster planning, gathering disaster supplies and training on radio procedures.

The AFG grant was accepted, and the Department is in the process of having vendors come to the station to demonstrate SCBA's. Bids will then be requested; the goal is to have new SCBA's ordered and delivered by the end of 2022.

Overall, my mission and goals have not changed. I continue to take care of the immediate safety of my crew and public needs as my highest priorities. If you have any questions, concerns or thoughts please let me know.

It is important that young children know their parents' names, address and phone numbers. Having some of that information allowed for these two kids to be brought home safely.

October is both Breast Cancer and Domestic Violence Awareness Month. You may see our staff wearing either pink or purple to show our support and to raise awareness for these issues.

Dear Mayor and City Council Members,

Public Works prioritized building maintenance and storm drain cleaning in anticipation of wetter weather. We installed a new catch basin and culvert pipe on SW 4th and Pacific Street. This will help with flooding on south pacific street. The month of September was productive for Public Works, lots of road work was completed and some other projects were started. Public Works added a no outlet sign and filled some pothole on south 4th and Miller Street this was done with the port's permission after receiving complaints from citizens. Public Works added a new do not enter sign and painted more one-way arrows on Nehalem Street to help identify the one-way road. We also added no parking fire lane signs and painted the curbs on North 3<sup>rd</sup> and North Pacific Street with no parking fire lane. I am happy to say that the city finally received a permit to do work on the Community Center. I have contacted the contractor and will get a work schedule when it becomes available this way, we don't rent out the building during construction.

The 3<sup>rd</sup> Ave. reservoir rehabilitation project started. Public Works did what we could inhouse to help lower cost. Water plant operators will have to work with the contractors and make operation adjustment during construction so that this reservoir project is completed safely. 3rd street reservoir booster station has two pumps that are used to fill the reservoir. These pumps use electrical motors and the motor on pump #2 has failed this required us to pull and send out for repairs. Looking at our records both pumps were rebuilt in 2004.

Water and sewer services have continued coming in steady. The City does constant required sampling of the public water supplies and some years OHA (Oregon Health Authority) require more sampling than others, this is one of those years. Public Works department is down one employee and with that said the crew is stepping up, covering when and where needed and I couldn't be prouder of their efforts.

The City's wastewater permit is in the draft steps, DEQ has summited our draft permit and gave us time to make any comments towards the permit. Public Works has made comments in a letter sent to DEQ and received good news.

The City Hall was painted, stairs were stained, bricks were sealed, the hole building got new gutters and down spouts, exterior lighting is next.

We will also be scheduling lift station cleaning this month during such cleaning it is normal to hear some noise coming from your sewer pipe.

1. **Policy:** It is the policy of the City of Rockaway Beach to provide assistance to non-profits and for-profit entities and organizations, who serve the Rockaway Beach community.

Community entities and organizations that serve the Rockaway Beach community, <u>but are not</u> <u>designated non-profits</u>, will need to meet at least one of the following criteria to be eligible for a grant:

- Provides assistance for essential utilities, food, medial needs, clothing or shelter.
- Provides educational or recreational opportunities for children or seniors.
- Generates/supports economic activate in Rockaway Beach.

In evaluating requests from non-profit and for-profits entities and organizations the city will consider the following:

- The requesting organization's history of success
- The organizational and financial stability of the requesting organization.
- The number and types of the community members served by the request.
- The ability to measure and track the effectiveness of the project or service.
- The community grant funds will not be used for travel, budget deficits or for routine operating expenses.
- II. **Purpose:** To set forth the procedures, terms and conditions under which the City will consider making grant awards to community entities & organizations as budgeted funds allow.

#### III. Procedures:

#### City of Rockaway Beach

- In reviewing the annual budget, the City Budget Committee will set an amount targeted for community assistance grants.
- Publish an announcement on the City Website announcing the city will be accepting Community Grant applications. The announcement will continue to run until the application due date.
- Collect date stamped applications until the deadline.
- Create a spreadsheet of all the community grant requests received.
- Schedule a regular City Council meeting for the City Council to discuss and determine who the grant recipients will be and the dollar amount of the grant. The City Council approves the grant recipients and amounts.

- The City Council approves the City Budget. The grant award is contingent on the Council's approval of the budget and appropriation of funds for the community grants for the upcoming fiscal year.
- Send a letter to the entities confirming grant amount awarded.
- Send a letter of regret to entities that were not chosen to receive grants.

#### **Community Grant Applicant**

- Submit a Community Grant application prior to the deadline along with a letter supporting the request. The letter should include how the funds will be used, including the benefit to citizens, number, and types (children, seniors etc.) of community members served, positive impacts to the community and any other information relevant to the request. Each evaluation criteria should be addressed for the application to be consider complete.
- Provide a letter to the City of Rockaway Beach upon completion of the project/or fiscal year end detailing how the funds were used. This shall include a leger of expenses and including recipes for all grant expenditures.
- Attend a City Council meeting and present how the money was spent, and how it benefitted the community.

Dear City Council,

Tides of Change is asking for \$5,000 from the City of Rockaway Beach Community Grant to provide emergency assistance to survivors of domestic and sexual violence. Last fiscal year, we served 40 Rockaway Beach residents and provided 1,760 services. Tides of Change, formerly the Tillamook County Women's Resource Center, has been operating in Tillamook County since 1982. Our mission is to provide hope, safety and support to those impacted by gender-based violence and to shift cultural norms through advocacy, education and community collaboration. Tides of Change provides free and confidential services for all survivors of domestic/dating violence, sexual violence, stalking and human trafficking. We provide safety planning, information and referrals, system navigation, accompaniment services, health advocacy, counseling and support groups, protection order assistance, emergency shelter, financial assistance and 24-hour crisis intervention, which includes operating a 24-hour crisis line. ToC continues to experience a high demand for our services and the support of the communities whose residents we serve allows us to continue to respond to those requests.

While our main advocacy office is located in Tillamook we do serve the entire county, and our advocates are able to respond throughout the county through mobile advocacy. Tides of Change works closely with local law enforcement through a partnership called Advocate Initiated Response (AIR), which the former Rockaway Police Department was a leading partner in the success of this initiative. The AIR protocol results in law enforcement immediately connecting a victim of domestic violence to a Tides of Change advocate once the scene is safe. The advocate will connect with the victim to provide safety planning, emotional support, and address any urgent needs such as medical care and access to a safe location. A goal of this initiative is that survivors will engage with advocacy services beyond the 1<sup>st</sup> contact and we have consistently had an 65% engagement throughout the initiative. Over the last 7 years, 20% of our AIR calls came from residents and/or tourists residing in Rockaway Beach.

We have provided emergency assistance to Rockaway Beach survivors 83 times over the last year for the 40 survivors that were served, and anticipate that these funds will support 30 survivors over the next year. The funds that we are requesting will help survivors access critical needs that they could not meet anywhere else such as: obtaining a driver's license, filing fees for a legal document, obtaining a bus ticket to relocate to a safer location with friends and/or family, access to emergency food and safehousing (limited hotel stays for survivors most at risk of harm). These seemingly small needs are critical for a survivor to be able to break free from the violence they have experienced.



Based on previous data we anticipate that the majority of the survivors served will identify as female; however, about 22% previously served were male. Most of the survivors will be adults between the ages of 25-59 while a few survivors will be teenagers and a few will be considered elderly. We expect those served by these funds will be similar demographics.

These funds will provide immediate support for survivors in Rockaway Beach that will increase their sense of safety and autonomy. Not only do these funds directly impact the survivors that would be served by these funds but the community as well. We know that domestic violence has direct and long-term impact on the overall workforce, devastating and costly public health impacts and in general increased risks for community safety. Tides of Change cannot address the impacts of domestic and sexual violence alone and we need the support of our local communities to help us serve their citizens.

#### Good Morning.

This is Debbie from Joes Snacks and Beer and I attended the meeting at the City Hall the other night and learned that there were grants that I could apply for. I appreciate the opportunity, We have never owned a business before and do not know how the Grants work. Mary on the City council gave me the information so that we could reach out to the City for help.

Our Business has been established for over 40 years with virtually one owner before us. It has been a staple in this community for many years and has been a pillar for many who enter it.

Both my husband and I are financially stable, my husband is still working his job to insure that the winter months are not to lean and that we can continue to service our community. We have embraced two of the charitable businesses in our area and realize there are many more that we can contribute to.

In buying this business and expanding on what we offer here, we found electrical issues in the entire building that were not addressed in previous years. The safety codes have changed and with the age of this building, now 104 years old, we find ourselves needing to update equipment and wiring as soon as possible. Insurance regulations have changed as well so we have many improvements to get done in a timely fashion.

One full day that the electrician spent fixing only 2 of many issues, was a total of \$1145.00. I have probably months worth of time still needed to fix lighting and electrical fire hazards. In total we are looking at \$10,000 approximately to get electrical fixed in both the lower building and our laundromat. We currently because of breaker box issues have 6 washers down which is over half and we are the only Laundromat for the community. We also have only half of the dryers working and need these electrical issues fixed before moving forward with repairs to the actual machines. Finding anyone available and knowledgeable to work on older machines is virtually been impossible.

Any help given would be appreciated. We are not asking for \$10,000 but just wanted to be up front of the repair cost we are looking at. We love our new community here and know that we will do our best to serve each and every person that

enters our doors. Community Outreach, helping seniors, charitable events, is something we both are passionate about. If there is an application I need to fill out could someone please send it to us.

## CITY OF ROCKAWAY BEACH, OREGON ORDINANCE NO. 22-xxx

AN ORDINANCE PLACING A TEMPORARY LIMITATION ON THE ISSUANCE OF NEW SHORT-TERM RENTAL LICENSES WITHIN THE CITY OF ROCKAWAY BEACH AND CREATING A NEW CODE SECTION IN CHAPTER 113 OF THE CITY OF ROCKAWAY BEACH CODE OF ORDINANCES

#### **RECITALS:**

- 1. On August 10, 2022 the City Council adopted new short-term rental regulations and created a new short-term rental license program.
- 2. The City Council is concerned for the health and welfare of the residents of Rockaway Beach and finds that short-term rentals can impact neighboring residents' enjoyment of the City and their property.
- 3. The City Council is also concerned with the health and welfare of visitors to the City that may stay in a private home acting as a short-term rental.
- 4. The City Council understands the wishes of owners that choose to rent out their homes on a short-term basis, so the City Council seeks to balance the wants of such owners with the wants of their neighbors that deal with the nuisance impacts that can result from vacation rentals.
- 5. The City Council desires to maintain a strong sense of community and not overwhelm neighborhoods with short-term rentals that impact livability for owner-occupied and long-term rental homes.
- 6. The City Council created the short-term rental license program in recognition of the desire of many owners to rent their property on a short-term basis and to provide for the orderly use and regulation of such rentals to preserve the health, safety, and welfare of the community.
- 7. In order to evaluate the short-term rental license program and evaluate possible changes to the program, the City Council wishes to place a temporarily hold on the issuance of new short-term rental licenses so that the City can determine the best next steps for the program.
- 8. In weighing the interests of neighbors, vacationers, and short-term rental owners, the City Council finds that this ordinance strikes the correct balance and during this temporary hold period, the City Council directs the continued study of the implementation of the short-term rental license program and possible improvements to the program.

### Now, therefore, the City of Rockaway Beach ordains as follows:

<u>Section 1.</u> The City of Rockaway Beach Code of Ordinances is hereby amended to add a new Section 113.06 in Chapter 113 as follows:

§ 113.06 Temporary Limitation on Issuance of Short-Term Rental Licenses.

(A) Notwithstanding any other provision of this Chapter 113:
(1) Except as otherwise provided in this Section 113.06, the City shall issue no new short-term rental licenses until July 1, 2024.
(2) The City may issue new short-term rental licenses for complete applications submitted prior to XXXXXXXXX.
(3) Short-term rental licenses may be transferred upon conveyance or other change in ownership of a rental unit.
(B) The temporary limitation on the issuance of new short-term rental licenses under this Section 113.06 does not limit the renewal of existing licenses.
(C) This Section 113.06 shall sunset and cease to govern short-term rental licenses on July 1, 2024.
Section 2. Severability Clause. A determination of invalidity or unconstitutionality by a court of competent jurisdiction of any clause, sentence, paragraph, section, or part of this ordinance shall not affect the validity of the remaining parts to this ordinance.
<u>Section 3.</u> Effective Date. Pursuant to the Rockaway Beach City Charter, this ordinance shall become effective on the thirtieth day after its adoption.
