2022 Annual Drinking Water Quality Report

We are pleased to present this year's Annual Water Quality Report (Consumer Confidence Report) as required by the Safe Drinking Water Act (SWDA). This report is designed to provide details about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. This report is a snapshot of last year's water quality. At the City we consider ourselves stewards of our community's water system and work diligently to maintain the level of quality and service our customers have come to expect.

Where does my water come from?

Jetty Creek, is a surface water source located a few miles North of town it has been used by the City since 1968. Ground water sources include two wells located within the Nedonna Beach aquifer and at 3rd and Manhattan Beach.

Current Events and Upgrades:

Over the past year, the city has been working diligently to maintain and upgrade our infrastructure. The city is currently working to install a Pressure-Reducing Valve (PRV) at the southern part of town, as well as installing a booster pump station to increase pressure on scenic view hill located north of town. The 3rd Avenue Reservoir Rehabilitation Project is well over halfway complete, and finishing touches will be finalized as weather permits.

A message from the EPA

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. These people should seek advice about drinking water from their health care providers. EPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the EPA.

Lead contamination warning

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Rockaway Beach Water Department is responsible for providing high quality drinking water but cannot control the variety of materials used in your homes plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: Microbial contaminants, such as viruses and bacteria, that may come from septic systems, agricultural livestock operations, and wildlife; Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, domestic wastewater discharges, mining, or farming; Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses; Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems; And

radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the number of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

MCL	MCL: Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
