1. Mountain biking presentation – Scott Grabke gave a presentation and answered some questions from the public and commissioners.
2. SB 406 & Housing Needs Analysis (HNA) – Fregonese gave a presentation about the recently passed Senate Bill to require missing middle types housing in residential zones and adopt housing

production strategies creating an HNA and updating comprehensive plans. Goal to be completed by 2025. Part of the senate bill includes funding for cities for updates. HNA SSP and Comp plan update.
