PRESENTATONS, GUESTS & ANNOUNCEMENTS

Tillamook County Community Development Director, Sarah Absher – Talked about SB406, that is currently under review in the State Legislation. Sarah also shared information regarding FEMA Biological Opinion.

STAFF REPORTS

Fire Chief Todd Hesse spoke on call volume for the Month of April. Hesse talked about trainings that the department focused on during the month of April, how the EMT Class will be wrapping up and testing will begin in June. Hesse stated that the Emergency Preparedness Fair was well attended with lots of valuable information given out. SCBA's are currently in the process of FIT testing and once all members are FIT tested, SCBA's will be in service. Hesse stated that preparations are being made for the upcoming summer tourist season, such as safety, training, and elevating emergency services during this time.

Deputy Grogan talked about call volume in the month of April. Grogan reminded the citizens to be more vigilant while driving with an increasing number of visitors, this will mean more traffic both on foot and in vehicles. Grogan stated that the Sheriff's office has a substation located on the main floor at Rockaway Beach City Hall.

Public Works Superintendent Dan Emerson spoke on what public works focused on during the month of April. Emerson talked about public works purchasing a new washer/dryer for employees to wash contaminated clothes before taking them home. The Playground at Phyllis Baker Park is starting to show signs of wear and required some maintenance, public works started to update and replace some of the toys. Emerson stated that they have been working with Advanced Excavation to install a pressure reducing valve vault on S. 2nd & Grayling. This project adds resiliency to Rockaways water distribution system.

City Manager Luke Shepard stated that there is a vacancy on the Planning Commission, applications will be posted online or be picked up at City Hall. The first street railroad crossing has been redone and is now finished. Shepard talked about the Emergency Preparedness Fair being well attended. The listening session for the Salmonberry Trail will be May 17th from 6-8PM at City Hall, all are invited. Shepard spoke on agenda items that the council will be talking about later in the evening.

He would also like to see the city hire a Parks & Rec Director to be able to bring that program back.

McGinnis joined the emergency preparedness group and is really looking forward to working with the group. McGinnis talked about attending the LOC conference and thanked the city for sending her. She mentioned how the railroad crossing at South 1st St. looks great. McGinnis thanked City Manager Luke Shepard for all the work that he is doing for the city, as well as the Lions club for putting on the backpack program for the children in the summertime. She wanted to encourage the citizens to check out the Chamber website for fun events in Rockaway.

MAYOR'S REPORT

Mayor McNeilly presented a presentation on greater connection and city governments. Mayor McNeilly stated to get the connection started that himself and City Manager Luke Shepard will be meeting at City Hall in the upstairs conference room starting the fourth Thursday of the month from 9AM-10AM opened to anyone who wants to stop by and bring questions, comments and suggestions.
