## **City of Rockaway Beach Business License Ordinances**

### **§ 110.02 LICENSE REQUIRED.**

No person shall as owner, operator, principal or as employee or agent of another, engage in, prosecute or carry on any business within the City of Rockaway Beach, unless or until the person shall have first obtained a license from the city therefore, and paid to the city the license fee therefore as hereinafter provided.

### **§ 110.99 PENALTY.**

(A) Any person violating any provision of this chapter shall, upon conviction thereof in the municipal court of the city, be punished by a fine not exceeding \$500, or suspension or revocation of business license, or by both a fine and suspension or revocation of business license.

(B) In addition to the penalties provided for in this section, and as separate and distinct remedies, the City of Rockaway Beach may sue in any court of competent jurisdiction to obtain judgement and force payment of any license fee due under this chapter.

### **§ 131.103 VENDING GOODS ON STREETS OR SIDEWALKS.**

No person shall use or occupy any portion of a street or sidewalk for the purpose of vending goods, wares or merchandise by public outcry or otherwise, unless approval has first been obtained from the City Council.

### **§ 131.105 OBSTRUCTION OF SIDEWALKS.**

No person shall place any objects, including but not limited to tables, chairs or sandwich board signs, which reduces the walking pathway to less than 4 feet.

### **§ 131.999 PENALTY.**

Violation of any provision of this chapter is punishable by a fine not to exceed \$500.
